D) Public Works & Parks:

Joe Rockwell said we have a new hire who started Monday. I need to get a Personal meeting together to discuss hiring 1 more to get to our 12. We have had 3 main breaks this past week, 2 in Fair Acres, I am looking at replacing that water main and whenever I get a price, I will be bringing that to you guys. IMEG will get me a price and update to EPA specs. I have tried to reach out to lowa Solar, and I have not heard back from them in over a year.

21) Comments from the Alderpersons:

Alderman Bob Cervantes said the good thing about being retired is that I will be out and about in my ward listening and talking to the folks in the ward.

Alderwoman Chrissy Winters said I went to the Parks meeting last month and they had said that people have been asking about additional Pickle Ball courts and I reached out to Amy, and she is working on some grants. I had someone in my ward reach out and ask me about the bike path on 10th Street by Hynd Farms, and I talked to Amy, and she told me that would be next year.

Alderman Joshua Dyer said so he thought the last meeting was pretty silly, but was handled with a lot of lavenosity, I said at the time that it wouldn't fix anything, and it wouldn't move us forward and it hasn't. I reflected a bit on some other things, some of the comments made. I appreciate some of the comments made about some of my rhetoric. I will point out that I am not the one who was swearing or exhibiting unstable or uninhibited behavior. I did not engage in name calling for the sake of name calling but I did label a person's actions. I think that is fair and I hope folks understand that. I will continue to call a spade a spade, that is the way dad did it and that is the way America does it and it has worked out well so far. I do have to correct some things from the last meeting though, I said that the resolutions came out by email at about 1:15, I was assuming at that time that they were included in the agenda packet and that I hadn't read

down far enough, it turns out that I was mistaken. They went out in a separate email about 4:15. Just 2 hours and 15 minutes before the regular meeting. When the Council had a vote of no confidence in the mayor, the agenda items were clear, they were clearly on the agenda and there was no attempt to conceal anything from the public or elected official. He had more than 48 hours to prepare for that meeting and apparently enough time to hire an attorney that he supposedly hired at his own cost and had the attorney attend the meeting. We had just over 2 hours. I find these kinds of railroading tactics abhorrent and I kind think that those who voted for the Resolution should be ashamed of themselves. When it comes to the resolutions themselves, I have to ask where did they come from? The resolutions that were passed where did they come from; I will yield for an answer. No one has an answer. Alderman Pirmann said the answers is that we all want to move forward. Alderman Dyer again said he wants to know where they came from. Alderman Pirmann stated he thinks it was all pretty clear at the last meeting but obviously, it wasn't enough, and it will never be enough, is it? We just need to move on. Alderman Dyer said he needs to know where they came from. They were drafted by somebody, who wrote them? Alderman Pirmann said they came from the Council. Alderman Dyer asked Alderman Pirmann if he drafted it, is that what you are saying? Alderman Pirmann said he doesn't even know what you are asking me. Alderman Dyer laughed and said there were 2 resolutions that were passed at the last meeting, and I would like to know who wrote them. Where did the document originate, who drafted it? Alderman Pirmann said it came out of 2 investigations and attorneys. Alderman Dyer again asked who drafted the document, and who wrote it. Alderman Pirmann said the investigations, we made motions. Alderman Dyer said yes to approve the resolution, the resolution was drafted by someone. Alderman Pirmann asked if he was just going to keep going on and on about this aren't you? Alderman Dyer said I just want to know where they came from, like they didn't miraculously show up on the desk, who wrote them. Nobody knows? Alderman Pirmann asked if it mattered. Alderman Dyer asked if the mayor asked for them to be drafted. Mayor Carter said we are moving on if you are wasting our council's time, if there is a point to this please get to it. We need to move on. Alderman Dyer said well if he could get an answer to the question. Mayor Carter said apparently you are not going to get an answer tonight so please move on. Alderman Dver said since no one is willing to admit where they came from. Alderman Pirmann asked if you had that would it matter, and Alderman Dyer said yes. Alderman Pirmann asked why. Alderman Dyer said Ancel Glink is not the only one who is capable of doing some forensic research into electronic files. Carissa Townsend is the one who drafted it, her name is all over it. She is an attorney with Ancel Glink, right? Attorney Heinle confirmed she is one of his colleagues. So, Ancel Glink apparently wrote it, and drafted it. Mayor Carter asked if you knew that, why did you ask? Alderman Dyer stated, I would like to verify that I was correct, but nobody wants to admit to it. Who gave the order for Ancel Glink to draft i?? Alderman Pirmann asked if we could just move on. Alderman Dyer said why can't you just let me continue with my comments. I yielded when it was your time, and it is my time now. Apparently, Carissa wrote it, it seems clear you can check the document yourself and see that Carissa Townsend, her name is the one that is listed as the author of it. That means that Ancel Glink drafted it, that means that Ancel Glink is charging the city for that work. Alderman Dyer said that Alderman Pirmann stated that these actions wouldn't cost the city a dime. You gave 3 things, 3 options, 3 options were given. One of them was to have that vote, the vote of no confidence or a censure vote in the 3 of us. That document was drafted by Ancel Glink and clearly the city is going to be charged for drafting those documents, Again, I

have to call a spade a spade, you said those actions were not going to cost the city anything, and they are. So, I guess that makes another liar. Alderman Pirmann told him Thank you! Alderman Dyer said that is all he has for tonight.
