Jerry said on the 16th of August we had the annual TIF meeting, the TIF attorney is putting together the TIF agreement that has been made, and it will go out to all the taxing bodies for their signatures. The Railroad Heritage Project on December 16th & 17th there will be a Silvis North Pole Express. We will do our best to help support that project. The Grow Facility is well on its way, phase 1 is just about completed. Rock River Coin and Jewelry, we did attend the ribbon-cutting ceremony and open house The Billboard company that I was talking to, it has kind of fallen flat. Illini Hospital, I have spoken with their CEO, and they are in the process of getting back to us with a proposal to either lease or buy some land up on Crosstown for a Dog Park. On Solar, Iowa Solar is owned now by Simply Ray and that would explain why they have not got back to us. They were unable to find a contract for the Public Works Building and neither was I, so we are working on that. Craig had some questions on the TIF agreement and Jerry clarified for him.

Silvis Lions Club is having a fundraiser on September 19th between 4 pm to 8 pm at Godfather's. I have been tracking the billing from the City of East Moline going back from 2022 to 2023 for our sewer bill, there was a problem with the reading system that broke, and they were waiting until this last month and that bill was significantly different so we will be looking at some serious credits on the last 6 months of sewer bills. I went to the Labor Day Celebration, breakfast with the City Clerk we talked to the head labor people, and we are trying to work on getting another tour of the Railroad Facility sometime in September. Steve Sandburg from the Railyard is looking for volunteers for the Holiday Train, decorations, a musician, a character, songwriter, or
