12) Comments from the Alderpersons:

Alderman Trulson said he wanted to make a suggestion that the property behind San Louis off 9th Street we have an Economic Development meeting to discuss selling that property to San Louis. No one can park there because they have their trucks parked there and we have not been enforcing time limit on our municipal parking. We can consider selling it to them so they can do what they want with it, or we need to start enforcing it and not park there all the time. I received a call from the library and as a reminder March 4th they are having their Bingo night in McGhee Center.

Alderman Pirmann said first rule of order form me, I want to have this removed from record. There was a memorandum that was sent out on December 19, 2023, from Ancel Glinck. In the second paragraph it says that because Alderman Pirmann participates in the city's health insurance plan and has engaged in advocacy in lowering plan health insurance premiums contributions for Union plan participants which will directly impact Alderman Pirmann. Alderman Pirmann has a direct conflict of interest. I would like that all to be stricken because none of that is true. I may have an interest, but I have never advocated to anyone to raise, lower, or do anything with the health care plan. I don't know where that came from, it would be nice to know but it is kind of slanderous to say something like that, that is not true. Absolutely not true. I would like the Council to be aware of that. I have never made that statement to anybody, and I am making it publicly that I have never made that statement, I have never advocated for the Union or against the Union. If I have advocated for anybody it has been for Team Silvis and it is what I have been doing since the day I got here. I would like you guys to all be aware of it and it be public. I would also like to know if all of the other Alderman have read the last latest and greatest offer? Have we read it? I haven't because I have been out of it. It would be nice to know if you have seen this document. The attorney told him we have reviewed it in Closed

Session. Alderman Pirmann said we need to be a little more honest with our information. Even though I am not in that meeting I still advocate for team Silvis, and we can only make decisions based on all of the information. You guys do not need to answer all of the questions, I think it is obvious what is happening. I am just trying to change the course a little bit and here is why. The reason I became an Alderman is because I felt like what I thought was Team Silvis was off track. We have seen derailments from our city in the last year and we are going to see more. We are not sharing data open and honestly and I think there is a lot of misinformation and my reason for it is again, I am guessing all of the Alderman have gone and read the Closed Minute meetings which we will talk about in Closed Session. I don't think, if it wasn't for Josh bringing this up and thank you for that, I read that document the original and I am guessing that Ancel and Glink revised that document and it goes back to the 5 July Closed Minute Meetings, I am not getting any details but the difference between the original and the revised document is so night and day. It is almost insane; I am sure you have all read it or I am hoping you read it. This is why Josh, and I are concerned, and you all should be, this is what happens when we are all not in charge as Alderman. Someone goes back and changes everything without our permission and I just want to remind the Council, and this is what Keri Lyn reminded me to do early on is to communicate with the Alderman in open Council, and this is what I am doing and was told was my job. We need to get the information straight the lawyers are working for us; we are not working for them. I am just being honest, fair and honest, not trying to be mean. Whether I am coming off harsh, I am sorry, we are all adults and we can all handle the truth, handle what is being said. We need to get our ducks in a row to move forward properly or we will have another derailment. Not because we want one but because we cannot stop what someone else is controlling. The conductor doesn't even let us know where we are going, we are in trouble. I hope you have all read the difference between those 2 documents, which is why I became an Alderman. That group that made that document and went into Closed meeting and did what they did, if any of you read that document and it was your spouse, husband or wife that was involved, you too would understand exactly what I was talking about. It was appalling what happen July 5, 2016, and it was my wife who got the shaft end of that deal and those people that were here know it. I am not going to throw names out it is on the document, so when we go to closed meeting, you will understand what I am talking about. I am not doing it to be mean or litigating, I am saying we need to get control of this ship before it is too late. We need these documents to come to the Council, we need to be honest and sincere. Mayor Matt Carter stepped in and agreed with getting control of this ship and in general we allow 5 minutes in our conversation for Public Comments and we are 7 minutes into it. Alderman Pirmann said he never got the chance to express it and he said sorry Matt I know this is disturbing and I am going to wrap it up than. Thanks for throwing me off, there was one more point I wanted to make but now my brain is off a little bit. That was very important for me to express.
