A) Fire Department:

If anyone wants to give some donations, thank you to Brian for your donations, Franks donated some stuff along with a few officers.

D) Public Works & Parks:

Joe said IMEG is doing shots and getting some great stuff done for Fair Acers, plan is right now to have the watermain and storm sewer done in the fall, and road done early next spring. 1st Ave sidewalk opening will be July 24th, got that confirmed today. Storm clean-up if you have people calling Friday will be the last day to pick up, as long as they have it by the curb, we will pick it up. 13th Street we will be hooking up on Thursday and all the services are done. 14th Street driveways will be cut tomorrow. Schadt Park update, we are going to power wash and seal and start laying the tile. Hopefully this week depends on how long it takes to get the clean-up done. I do have the trucks ordered and we are looking at September/October delivery. Mayor asked how many men he has with CDL completed and Joe said we have 3 left to get it and we will have 9 who will have it. Alderman Pirmann asked how many of the crew have a water certificate and Joe said he is the only one. Alderwoman Winters asked about the lift station on 28th and 29th and Joe said he is waiting for them to tell him when they are coming to put the device in. It was delivered last Friday.

Alderman Trulson said he would like to extend his thanks to all the city staff and employees for the last couple of days. He wants to extend his apologies to the citizens of Silvis because I really think that we missed a huge opportunity to save the city money, benefits etc. Alderman Greer said thanks to everyone city, fire, police. I drove around last night, and it was kind of crazy with how many service vehicles were out. Our streets were lite with all those lights, everyone was doing a great job. Everyone who was involved in the clean-up thank you. Alderwoman Winters said she just wanted to thank everyone as well and remind you that we are having our Summer Fest for Silvis Main Street on August 3rd. Craft show, Car show, Rabbit Hole will be performing from 5 to 8. It should be a great time; we are going to need some volunteers so please reach out to me if you have free time. Jerry asked if she had any artwork for the Summer Fest so we could put it up on the billboard and she said she would get it to him. Alderman Dyer said thanks everyone for cleaning up the city you did a great job. Joe, I wanted to commend you for handling some criticism earlier. As far as Solar goes, this is a gigantic opportunity that was missed. The proposal would have reduced the cost to run the city, like that fact is the definition of responsibility. The incentives will not be there in 8 months, this whole project will cost more than and I don't understand why this was voted on previously 7 to 0 and now it goes 5 to 3. I think the citizens should go shopping for new Alderman and a new Mayor next time.
