Alderman Pirmann asked a question if Roger could keep a total on that, our itemized cost on this. Roger said he was already doing that.

Saturday, we have the Trunk or Treat at the library at 5 and the train event from 9am to 4pm. Alderman Pirmann asked a question: Have you had a chance to looking into MP3 on the website or add it on? Amy said they are working on a few things this week and they are working on it. She is working with IT and she is working on having both. Alderman Pirmann's next question was he noticed on the agenda we do not have Alderman comments is this an oversight or just standard policy? Mayor said it is now standard policy, we do not need it on there. Alderman Pirmann said there are no more Alderman Comments and Mayor said no there are not. Mayor said he decided that. He is tired of negativity, if you want to say something positive you are more than welcome to raise your hand at the end of the meeting and say something positive. Positive Silvis. Alderman Cervantes asked if this was the procedure in other cities and mayor said that East Moline, Moline and Rock Island do not have them.

# 8.6) Mayor's Report:

Mayor Carter said he handed out some things. John McGregor, which is the airport commissioner, has resigned due to work constraints. I asked Chuck Cervantes if he would be interested in that, he is interested and is right now also serving on the Civil Service as Chair of that. There is a conflict with him being on another board or commission if he is to be on the airport authority. Chuck would like to accept the position of the airport authority and would resign from his other position. Chuck has been with the Civil Service for well over 10 years and he welcomes the changes. The board out at the airport is a difficult position to fill, it is a Tuesday morning position as well. Chuck had a conversation with the airport and vented through them as well and they recommended that he would be an asset. Alderman Trulson asked if this needed to be approved by the Council and it is not on the agenda and mayor said yes, he was going to put it on his speaking time and ask for it to be put on the next agenda. I do recommend him for the position. We will also put his acceptance of his resignation on the agenda as well. The next thing is the Fire Department. He asked the firefighters in the audience to introduce themselves and Caption Josh Fox spoke for everyone about how they are all going to divide Chief's jobs up between them so that the council doesn't have to find an interim Chief until after the election. After the election the new mayor can find a new chief. John made a list of all jobs with Dave Rice being the assistant chief taking on the lead. Mayor said we will have to have a Finance/Personal/Ordinance meeting to discuss compensation for the added responsibilities and split. There is about 6 months of John's payroll left to help out. The list that was passed out has about 205 years of experience, we are well taken care of with this and thank you all so much with your help on this. We are still working through the state statute on that with the interim and we have been talking to the attorney. There are some things that have to be worked out from a legal perspective, and we will have answers on Monday. I have never seen the Silvis Fire Department fail, especially when we all put our heads together. Reminder the police chief will be gone this Friday and all next week. Alderman Pirmann asked if the mayor has addressed our Ethics committee in the last year and mayor said no. Alderman Pirmann asked why and mayor said he has had no reason too. Alderwoman Winters asked who is on the Ethics committee, mayor said it is on the website. Ben Lovelady, Josh Fox and Gail Vyncke. Mayor asked the attorney what the role of the Ethics committee is, and Roger gave a description. If there is a question Roger would help with it, but he has never been asked a question since he has been on the council. Mayor asked if he was the chair for that committee and Roger said he is not formally the chair. He would evaluate the question and help direct it to where it needs to go.
