They are wanting to sell the building, the reason for the move is they outgrew the building. Iron and Grain have defaulted as well, they have been sent a default letter. They need to go to collections; they owe around \$42,000. We will have an annual review about TIF's at City Hall in mid-January. Charged Coffee closed, it was for personal reasons only business was doing well. They were in business for just over 4 years, just under \$8,000 is owed back to the city and they have been sent a default letter. Kelly's Pizza had a 6-month extension to have it built and open and they will not achieve that. I did make contact with the owner, and they had a lot of excuses. They will also be in default and there is no lien on that property. Total we loaned them was \$50,000 built within a years' time.
