At least get the water main in by May 1<sup>st</sup>. As far as the water main break, we get a lot a comments about Moline water and that is why we are getting the breaks and that is totally false. It is old pipes and pressure; we are fighting stuff from the turn of the century.

### **10) Alderman Comments**

Alderman Tony Trulson said he had a question for Joe, Schadt Park? Joe said we will get there once it is dry, it will not take us long. Tony also wanted to ask Finance to please remember hopefully to budget solar arrays for this fiscal year and to ask Jerry to get a new bid. I want to say Thank you to Tom Cassidy, Darren and the rest of the Fire Department for volunteering to take on more responsibility. Tony said that something that has been bothering him lately is the more and more juvenile crimes that are being committed. The question is why are we not doing something about it, where are the police? There is no punishment or deterrent when these juveniles commit these crimes. I would ask if we can work with other municipalities to make stiffer punishments for these crimes. I want to ask for some task force for the city of Silvis to work on this.

Alderman Doug Greer said having work with kids and the school system the courts will not pay for it, they do not want to pay for it. I want to say great job to Tom and how we are working forward with our Fire Department.

Alderman Craig Pirmann said please pass on to Tom Cassidy that he took on a completely different approach, but it is baby steps, and it is a good opportunity to get our feet wet. I did want to find out about budget timing because I have not heard anything, and I hope we do not wait until April. I also have 2 ideas for ARPA funding and Amy said she has the list, and it will be at the next meeting.

Alderswoman Chrissy Winters said I appreciate you Darren, explaining everything and meeting with each of us individually to discuss it. I am happy to see the Fire Department the way they are right now. The only other thing she has is Main Street and our 2<sup>nd</sup> annual Euchre Tournament on March 7<sup>th</sup> at 5:30 at Ave Tap. We are looking for baskets so if anyone wants to donate, let me know. We only have 7 teams left, it is \$50 a team and it gets you something to eat. Called a Finance meeting.
