Congratulations to Gene, I have known Gene for a long time and no doubt he will take the PD to the next level. Looking forward to passing information on and collaborating with him before I go. He is in great hands. I would also like to give a shout out to Sargent Vargus & Sargent Miletich who put in for that position. They put themselves out there and they presented themselves well from the feedback I got. We have a great crew of cops and I am sure Gene will take it to the next level, and you have my word that will happen. It is kind of bitter sweat with me being here for 10 years as your Police Chief, but no doubt I will make it as seamless as possible. Alderman Pirmann asked I am seeing an increase in our homeless and I mentioned it to Copeland at last meeting. I am hoping we can get together and spearhead some ideas. The other issue is the unbelievable number of wild cats. It is out of control, in the woods by our house there are at least 6 and they are growing. I don't know if there is something we can do. Chief said we can trap them and Pirmann said well we need to let people know that we need to do something about it. Amy asked Chief to touch on Citizens Police Academy. Chief said if you want to get involved in that program. Meet the QC officers, see what we do. We have run it for the last 2 years and this year it has been passed to East Moline. January through April on Wednesday from 6 to 9pm. Amy will send out applications, and they will be available online.

D) Public Works & Parks:

Joe said 14th St. watermain is getting replaced and it is underway about another week and a half and everyone will be hooked up.

10) Alderman Comments

Alderman Doug Greer said he would like to welcome Gene and Mark you will be missed. I also want to say that our city looks good with everything getting done. It looks nice so thank you. Alderman Steve Marinaccio said to Joe thanks for getting that hole filled in on 3rd Ave and 13th. It looked like it was going to grow into something nasty.

Alderman Dave Rice said welcome aboard Gene, I have also known him for a very long time. Chief it has been a pleasure, and I have always thought highly of you and always will. I think you did a great job for this city.

Alderman Joshua Dyer said the person who spoke earlier alluded to it, if the gift is over \$25 it is an illegal gift. I was contact by an Alderperson from East Moline, they are in contact with Greg Johnson's office and they are looking to stock the Riverbend Food Bank given the government shut down and everything they are trying to find a way to get people to again to donate more food but also to make it more convenient to donate that food. One of the things they identified as a bottleneck is that Riverbend is only open during regular business hours or while people are working. The thought was that the Fire Departments be able to accept donations and someone from Greg Johnsons office would come around and collect those donations. That has grown and it sounds like we are going to have to coordinate a little bit, and I have volunteered to be the person in Silvis to pick up the food from our Fire Department and I talk to Chief Johnson and he said yes, it is fine, especially on the weekends. That was a particular time the Fire Department

would be open and there to except donations. If people want to stop by and deliver food to the FD, I would be happy to go pick that up and get it to Greg Johnson's office and then they will get it to Riverbend. This is an effort that is going on across the QC, and she wanted to get Silvis into it as well. The other thing was I wanted to talk about what I thought was just a cowardly act that we witnessed at the last meeting. Everybody seems to be afraid to have a conversation. That is what the whole motion was on Solar was to have a conversation, but people didn't want to do that. It is frustrating when people are lying to my face saying I am really glad you brought that back up or you know I am actually in favor of Solar but then they vote against it or when someone says to me I will listen to whatever you have to say but then they don't afford me the ability to say it. I think it is really sad that people are afraid to have a conversation around here. I am sure you all have a really good explanation to our citizens as to why you want to spend an extra half a million dollars on electricity.

Alderwoman Chrissy Winters said I just wanted to make sure everyone is aware with the food crisis and everything that Hy-Vee is actually offering 12 and under free meals Monday through Friday and then also if you are over 12 you can get that meal for \$3 no questions asked.

Mayor Bob Cervantes said we have our Veteran's Day service November 11th at 11am, I would really appreciate it and be grateful to the Alderman and City Staff to come out. In the past we were lucky to get 1 or 2 of you to come out. This is remembered by the people who put you into office. They ask where are your Alderman? If you can, just let me know that you can't be there because you have other stuff, but I would appreciate it if you folks can come out. We have Veterans from our police chief to our administrator. It shows a little respect for them. George O' Barr has their Veteran's Day Service starting at 8am, with coffee and donuts and the service starts at 8:30am. Myself, the administrator and the Clerk are all going up there. Chrissy has her own service at Colona so she can not come.
