Jerry said he wanted to ask the Committee members of Economic Development and Finance to consider calling a meeting to revisit the possible TIF agreement with Strictly Southern. They would like to come back and talk to the committee, there are a couple of things we can address, and the committee can come up with recommendations to the Council or if they are ready to go straight to Council. We need to come up with something to bring back to Council, the owner would like to attend. Monday the 12<sup>th</sup> would be that day for the meeting. The next thing I have is in the water bill info went out on the Tri-City's Housing Lottery. East Moline, Moline, and Silvis have worked together collectively to secure a grant through the state for 1.2 million dollars. There will be 25 projects selected for this at random, it will be live and in zoom at the Moline Public Library. This will be for homes for repair, it will be for certain people who meet a lower income level and are trying to stay in their home as a scenario, that could be handicap ramps, roofing, siding, painting or fencing. Whatever they may need to stay in their homes. On January 12<sup>th</sup> from 9am to 5pm I will be here at City Hall if anyone needs help registering for that or you can do it online. It is a 1-day event and a short window. I will leave the qualifications up front; it is also on the water bill and on our FB page. On Thursday some of the media stations will have it on the news. If we do not spend 1.2 million on those 25 projects, we will have another lottery to continue it on. We are hoping to do this each year. We have been hand delivering some of these to the houses we know can use this.
