#### New Parking Coming To Downtown

The City of Silvis recently acquired the properties at 116 9th Street and 119 8th Street with TIF redevelopment dollars. Demolition of both properties will be nearing completion, an estimated 50 new public parking spaces will take its place. "Increased parking near 1st Avenue will help open the door for additional growth in the older retail sector," says Mayor Carter, adding "Silvis has made investments in the streetscape, LED lighting, façade programs, along with TIF to attract new business and it's beginning to pay off." The traffic count on 1st Avenue averages 12,000-15,000 vehicles per day according to Illinois DOT. The advantage 1st Avenue has over other older neighboring cities is traffic, says Carter. He considers 1st Ave. "a diamond in the rough, but only the visionaries will recognize it."

# Renovations With A Dash Of BBQ Sauce



William Strickland has big plans for an old iconic building in the 800 blocks of First Avenue. Mr. Strickland, owner of Strickly Southern LLC re-

cently purchased the old iconic American Café. Renovations of the threestory building estimated at \$300,000. His plans include six apartments and two commercial storefronts. Strickly Southern BBQ's commercial kitchen location will be in the back half. Strickland says "a neighboring city had many more buildings to choose from, but Silvis was a much better choice. Silvis is much more organized and is making improvements, and I live here, so it just made sense to keep local."

need to be mindful of the hidden dangers associated with house fire during the winter months. According to the American Veterinary Medical Association, 40,000 pets die every year in house fires. The National Fire Protection Agency reported 3,515 human deaths in 2017, the second most common cause of house fire was heating. Please refrain from attaching an extension cord or any other device to a space heater, space heaters are designed to plug directly into a wall outlet. Also, keep other combustible materials clear from a space heater at all times.

(a) The occupant of the property abutting the public right-of-way or the owner thereof if said property is vacant, or any person acting as the agent of either, shall have the following duties in relation to said public right-of-way.

- To remove within a reasonable time from the portion of any public sidewalk abutting said property of snow and ice.
- To refrain from putting, pushing, blowing or otherwise depositing any snow removed from the public sidewalk or private property upon any improved public roadway.

(b) For the purpose of this section, "reasonable time" shall mean as follows: Within 24 hours after cessation of snowfall, or if a snow fall ceases in the nighttime hours, within 24 hours after rise.

(c) It shall be unlawful to pile snow in such a manor as to hinder the sight of motorist.

Navigating with a snowplow becomes increasingly difficult when waste bins are left in the alley. The Public Works Department asked if you could please remove your waste bins from the alleyways after they have been dumped.
