Silvis Police Chief Addresses Community Concerns

The Silvis Police Department, in collaboration with other area police departments, has an ongoing relationship with the NAACP. The partnership lays the groundwork for collective ideas to strengthen police/minority relationships and minimize force encounters.

Silvis, along with other area law enforcement agencies are currently in talks to adopt the "10 Shared Principles" resolution, which addresses devotion to treating everyone, regardless of race, creed religion, sex, and other protected classes, with value and respect.

In 2019, Silvis Police, with the consent and approval of the City Council, implemented a body-worn camera (BWC) program for transparency and accountability.

Currently, state law bans the use of chokeholds unless it is a deadly-force encounter. The Silvis Police Department follows the use of force continuum, which dictates what level of force an officer can use on someone.

Since 2015, Silvis Police Department has conducted yearly training on implicit bias, racial profiling, cultural competency, deescalation, and mental health awareness.

The police department recently enacted "Use of Force" reports, which allowed senior personnel to track officers' use of force and aids in accountability.

The Silvis Police Department is currently taking part in focus groups, directed by the NAACP, using street-level personnel to begin a dialogue with members of the minority community and other local stakeholders.

The Silvis Police Department believes in the fair treatment of all and believes in working with our citizens and Council members to control crime. A valued relationship benefits all citizens.



Storm Weather Siren Upgrades

Fire Chief John Winters attended a conference on July 21st with the Rock Island County 911 Board, the National Weather Service, and Federal Signal regarding storm sirens and warnings.

After the 2019 consolidation of police dispatching of Silvis, East Moline, Moline, and Milan, which is now known as QCOMM 911, the board began work on streamlining the emergency warning systems for the four communities.

In the past, QCOMM 911 dispatch would manually set off storm sirens. In some parts of the county, the dispatcher could not set off sirens and would require someone from the fire department to set the sirens off manually.

The Rock Island County 911 Board recently purchased new software and required hardware to provide storm siren system upgrades without manual engagement. The new software will link all 39 sirens in Rock Island County together, two of which are located in Silvis.

The protocol for all dispatch centers is to sound the alarms every 10 minutes as long as a National Weather Service warning is in effect. This can be a difficult task for dispatchers when violent weather strikes with an increase in emergency calls during a storm.

The ultimate goal along with the new upgrades is to provide quicker and more accurate warning sirens, fewer sirens activated in areas not anticipated to be severely affected by weather, and allow emergency dispatchers more time to focus on added calls during severe weather.
